YOUR DOG NEEDS A LICENSE

It's the Law!

Failure to comply could mean a fine of up to \$300.00 per day

If you have previously purchased a **2009 Dog License** for your pet, **PLEASE DISREGARD THIS NOTICE as you are in our database and will be receiving a renewal notice shortly in the mail.** Otherwise, it's important to know that Allegheny County residents who fail to purchase a 2010 County License for their dog(s) age three months or older, are violating Pennsylvania State Law. **THE FINE IS UP TO \$300.00 PER DAY FOR EACH UNLICENSED DOG.** City of Pittsburgh residents must contact the Mayor's Service Center to obtain a dog license; all other county residents must contact the Allegheny County Treasurer's Office.

Not only is it the law, but a licensed dog is **protected** if lost, as well. All local Police Departments throughout Allegheny County are networked into the County database and can easily locate the owner of a lost dog just by the Dog License number that appears on the tag.

The State Dog Warden for the Bureau of Dog Law Enforcement has indicated that he will be canvassing the area during the next several months. Owners of any unlicensed dog will be immediately cited, fined and prosecuted.

PA State Law requires all owners to obtain dog licenses by January 1st of each year. As a convenience to county residents, County Treasurer John Weinstein is providing an **Allegheny County PA Dog License Application** on the reverse side. In addition, official license applications are available on the Allegheny County website at www.alleghenycounty.us/treasure/dog.aspx, the Allegheny County Treasurer's Office, Borough or Township Municipal Buildings and must be mailed or delivered to the Allegheny County Treasurer's Office. Please note that individuals with a disability or Senior Citizens receive a discount as well as licenses for neutered and spayed dogs are available at a discounted price.

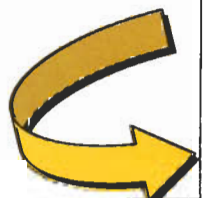
